Söz konusu düzenleme kamu bütçesinden finanse edilen ve SA Kamu Alımları Kanunu kapsamında yapılan ihaleler için öngörülmüş de, ARAMCO ve Kamu Varlık Fonuna (PIF) bağlı şirketler gibi anılan kanunun dışında olan doğrudan ya da dolaylı şekilde kamuya ait şirketler tarafından "gönüllü" olarak uygulanabileceği belirtilmekte olup, detaylı bilgi ekte iletilmektedir. 03.19 Regional Headquarters (RHQ) License

Service Description

This service is provided to Multinational Groups wishing to establish their RHQ in the Kingdom as a unit duly established under the laws of Saudi Arabia for the purpose of supporting, managing, and providing strategic direction to its branches, subsidiaries and affiliates operating in MENA region.

3. The annual audited consolidated financial statements of the last financial year of the applicant, attested at the level of the Saudi Embassy in the respective country.
