INTRODUCTION

Every year on October 14, the Republic of Tajikistan celebrates Entrepreneur's Day, one of the country's key professional holidays, symbolizing recognition of the role of the private sector in national development.

In observance of this day, the State Committee on Investments and State Property Management, with the support of the Government of the Republic of Tajikistan, annually organizes a number of events aimed at recognizing the contribution of the private sector to the country's socio-economic development.

Traditionally, the celebration of Entrepreneur's Day in Tajikistan is not limited to a single day but grows into an entire week of cultural and business events across the country — forums, exhibitions, round tables, and B2B meetings — culminating in a central ceremony attended by the country's top leadership.

For example, in 2025 the main event was the “Dushanbe Invest — 2025” International Investment Forum, held on October 14–16 in Dushanbe with the participation of the Leader of the Nation, the President of the Republic of Tajikistan, the esteemed Emomali Rahmon, and other high-ranking guests and investors from foreign countries.

This year, in honor of this holiday, the Meeting of the President of the Republic of Tajikistan with Entrepreneurs and Investors and the Entrepreneurship Forum “Tojikiston ba pesh!” will be held.

The events will take place on October 14–15, 2026, at the state complex “Kokhi Vahdat,” located at 107 Rudaki Avenue, Dushanbe.

The Meeting of the President of the Republic of Tajikistan with Entrepreneurs and Investors will be held in the first half of the day on October 14. In the second half of that day, as well as throughout the day on October 15, the Entrepreneurship Forum will be held under the theme “Tojikiston ba pesh!”, which includes thematic forums, expert sessions, side events, an exhibition, networking events, and other activities

bringing together representatives of government bodies, the private sector, international organizations, development partners, and investors.

This Concept describes the goals, format, and program of the above-mentioned events, as well as the approaches to their organization and the expected outcomes.

MAIN GOALS

The main goals of the events are to strengthen constructive dialogue between the state, the business community, and international partners, to create favorable conditions for the development of entrepreneurship and investment activity, and to promote the Republic of Tajikistan as a reliable and competitive destination for doing business and implementing long-term investment projects.

Holding the event is also aimed at discussing key issues in the development of the business environment, improving investment policy and public-private partnership mechanisms, expanding international economic cooperation, supporting innovation and technological entrepreneurship, attracting domestic and foreign investment, and developing practical solutions that contribute to the country's sustainable economic growth and the competitiveness of the national economy.

PROGRAM

The central event of the first day — October 14 — will be the meeting of the President of the Republic of Tajikistan with representatives of the business community and investors, which serves as a key platform for open dialogue between the state and the private sector.

Following the plenary session, two specialized forums will be held, dedicated to the development of public-private partnerships (PPP) and venture investment.

On the morning of October 15, the Insight – G10 Forum will be held, which will focus attention on global trends in entrepreneurship, investment, innovation, the digital economy, and sustainable development.

The Forum's program also includes side events, an exhibition of achievements of domestic entrepreneurship and investment projects, as well as a cultural program.

The structure of the forum's program is provided in the appendix.

PARTICIPANTS

The event is held in the format of a high-level national dialogue platform, bringing together representatives of government authorities, the domestic and international business community, investors, financial institutions, international organizations, and the expert community.

Participants in the event will include heads of government agencies, representatives of domestic and foreign business, international financial organizations, development institutions, the diplomatic corps, industry associations, the banking sector, investment funds, the scientific and expert community, as well as young entrepreneurs, representatives of the startup ecosystem, and venture capital.

EXPECTED OUTCOMES

Holding the event is intended to produce three key outcomes. First, policy synergy — clearer alignment of state economic priorities with private sector initiatives. Second, identification of strategic initiatives — highlighting key projects deserving state support and private investment. Third, expansion of business ties — strengthening a permanent platform for cooperation between domestic entrepreneurs and international development partners.
